In consideration of participating in the San Fernando Valley Veterans Day Parade, I represent that I understand the nature of parade events and that I and/or my minor child am qualified, in good health, and in proper physical condition to participate in such activity and upon which traffic hazards are to be expected. I acknowledge that if I and/or my minor child believe event conditions are unsafe I and/or my minor child will immediately discontinue participation in the Activity.

I fully understand that the parade event involves risks of bodily injury, which may be caused by my own actions, or inactions, those of others participating in the event, the conditions in which the event take place, or the negligence of the "releases" named below, and that there may be other risks either not known to me or not readily foreseeable at this time; and I full accept and assume all such risks and all responsibility for losses, costs, and damages I and/or my min or child incur as a result of my and/or my minor child's participation in the event.

I hereby release, discharge, and covenant not to sue San Fernando Valley Veterans Day Parade, its respective administrators, directors, agents, officers, volunteers, and employees, other participants, and sponsors advertisers.
